Rules & Regulations he Pueblo de Cochiti Governor's office, with the support of the Tribal Council, require all vendors adhere to the following guideline that promote a healthy environment for our youth, families and visitors. Please initial as acknowledgement of terms and conditions.
Pueblo de Cochiti has the right to refuse sale of a vendor permit to any individuals.
Pueblo de Cochiti tribal members will NOT be allowed to sell during this time. (i.e. vending area or outside homes)
Booth Space are on a first come first serve basis. <u>ALL</u> Native American vendors must provide a Tribal ID or Certificate of Indian Blood (CIB) at the time of booth purchase.
Booths must be paid in full to reserve a space. This includes day of booth purchase (if available).
Prices are subject to change without prior notice.
All vendors are only allowed to sell in the designated areas. Sales are not allowed within the immediate area of the pla
Vendors selling Novelty items: Weapons, knives, disappearing ink, colored hair spray, fart spray, laser pointers, and any items that promote profanity, alcohol slogans smoking paraphernalia, or gang related items are NOT ALLOWED.
All FOOD BOOTH workers must have a valid Food Handlers permit. Permits must be visible for the duration of the Fea Day. Indian Health Service representatives will be making rounds to inspect food booths, throughout the day. Food Ven are responsible for the disposal of grease and gray water. Pueblo de Cochiti does not allow dumping on-site or on puebl land. Vendors are responsible for all trash disposal, in the designated bins.
On Feast Day: Vendors will be allowed to set up between 6am-9am.
Prior to setting up, Vendors MUST check-in with the Registration Booth - located on Pumpkin St.
Vendors will not be allowed to set up after 9:00am. Unoccupied spaces will be sold after 9:00am. For the duration of the feast day - VENDOR PERMITS MUST BE VISIBLE
Alcohol and Drugs are strictly prohibited on Pueblo de Cochiti lands.
Picture taking, video recording, and/or sketching is prohibited. Devices are subject to confiscations and/or fines.
NON-COMPLIANCE of these rules and guides lines will be subject to fines up to \$1000.00 and/or appearance in Pueblece de Cochiti Tribal Court.
